HOWLAND FIRE CHIEF- MAT EXPRESSED HIS NEED FOR INFORMATION IN THE PROPER DECISION MAKING FOR THE TOWN REGARDING FIRE/EMS SERVICES. ASKED CHIEF MCNALLY THE PLANS OF HOWLAND FIRE. JOSH DISCUSSED THAT HOWLAND FIRE HAS PROVIDED FEASABLE SERVICES FOR ALL COMMUNITIES AS WELL AS REGIONALIZATION. JOHN SPOKE ON BEHALF OF BURLINGTON AND THE MERGE WITH HOWLAND. HE STATED THATTHE COST HAS BEEN MORE AFFORDABLE TO THE BURLINGTON TAXPAYERS AND HAS GONE WELL FOR BOTH COMMUNITIES.
