JESSE EXPLAINED THAT CURRENTLY THEY ARE ESTABLISHING REMOTE ACCESS FOR THE COMPANY SO THAT THEY CAN BEGIN USING OFFSITE ACCESSIBILITY TO THE TOWNS REAL ESTATE SOFTWARE AND ARE WORKING WITH I.T. TO SET THAT UP FOR THEM.
