FOGG BROOK RD- RICK MARVEL WILL BE CHECKING WITH WES DUBE ABOUT GRADING.

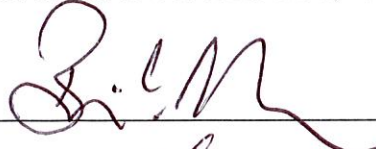
NEW BUSINESS:

GA ORDINANCE- Pursuant to 22 M.R.S. § 4305(1), the municipal officers of the Municipality of LOWELL, after notice and hearing, hereby amend the municipal General Assistance Ordinance by repealing and replacing appendices A through G of the existing ordinance with the attached appendices A through G, which shall be in effect from October 1, 2022, through September 30, 2023. This amendment will be filed with the Maine Department of Health & Human Services (DHHS) pursuant to 22 M.R.S. § 4305(4), and a copy of the ordinance and amended appendices shall be available for public inspection at the municipal office along with a copy of the 22 M.R.S. chapter 1161.
