CHUCK IS GOING TO ORDER THE METAL FOR THE BACK OF THE SALT SHED AND PHIL STANTON IS READY TO MAKE THE REPAIRS WHEN THE MATERIAL ARRIVES.

IT WAS DECIDED THAT THE HOLIDAY IS ON THE  $4^{TH}$ , THEREFORE THE OFFICE IS ONLY CLOSED ON THE  $4^{TH}$ . THE WEBB COVE ASSOCIATION PRESIDENT BRIAN LIBBY HAD COME TO THE OFFICE REQUESTING CALCIUM FROM THE TOWN. THERE IS AN OLD POLICY IN PLACE WHICH STATES WEBB COVE RESIDENTS MAY BE GIVEN A BAG CALCIUM AT THE SELECTMENS DISCRESSION.
